

PARTICIPANT AGREEMENT and WAIVER, RELEASE & INDEMNIFICATION AGREEMENT
Camp Timanous Reunion Weekend

Please read this document carefully. By signing this Participant Agreement and Waiver, Release & Indemnification Agreement (this "Agreement"), you are releasing Camp Timanous from all liability and foregoing all claims.

The following guidelines (the "Guidelines") are designed to ensure that the Camp Timanous Reunion Weekend is a happy, safe, and productive experience for everyone. Here are the conditions under which we accept your participation. Read them carefully. All attendees are expected to adhere to the Guidelines.

You will be asked to affirm your commitment to these Guidelines by signing this Agreement upon check-in at the reunion. Refusal to sign this form or upon a violation of any of these Guidelines or camp policies ***may subject you to immediate dismissal from the reunion without a refund.***

1. The Camp Timanous community relies upon each member making a positive contribution. Respect for others and self is required.
2. Reunion Weekend is a B.Y.O.B. (Bring Your Own Beverage) event. Attendees age 21 and older are permitted to consume alcohol throughout the weekend. Everyone is expected to consume responsibly and at all times to respect camp property, staff and all event participants.
3. No person age 21 or older may purchase or provide alcohol to any underage attendee.
4. No attendee under the age of 21 may consume alcohol at any time during the Reunion Weekend.
5. The use or possession of marijuana, or any other controlled substances or drugs is not permitted at camp.
6. Tobacco use is permitted only in designated areas.
7. Weapons of any description, fireworks, and any other incendiaries are not permitted in camp.
8. Campfires must be lit, maintained and extinguished by designated individuals only.
9. Everyone must adhere to program area rules. Camp and event staff have authority in each respective area. Lakefront use is permitted in accordance to the safety and waterfront regulations attached. Ropes/Wall are off limits at all times unless otherwise indicated.
10. For the respect and enjoyment of all guests, camping and socializing is to occur in designated locations only. Council Fire and the Farmhouse lawn are the only areas open to guests across Plains Road.
11. Parents must accompany their children at all times.
12. Each attendee of the reunion is expected to contribute to keeping camp facilities neat and tidy by cleaning up after themselves and leaving their cabin at the end of the weekend as they found it upon arrival. Graffiti and other forms of vandalism are not tolerated.
13. Respect for indigenous animals and plants around camp and the natural environment in general is expected.

Acknowledgment and Assumption of Risk

I, on behalf of myself and/or in my legal capacity as parent and/or legal guardian of the minor named below ("Participant"), acknowledge and agree that any use of Camp Timanous facilities, services, tools, equipment and premises ("Facilities") and any participation in Camp Timanous programs and activities during the Reunion Weekend ("Programs") involves inherent risks, both known and unknown. I acknowledge and agree that I have full knowledge and understanding of the inherent risks associated with attending and participating in Programs. I voluntarily, for myself and/or Participant, accept and assume full

responsibility for these risks as well as any and all other risks arising out of or in any way related to the use of Facilities and participation in Programs.

COVID-19 Warning & Disclaimer

Coronavirus, COVID-19 is an extremely contagious virus that spreads easily through person-to-person contact. **COVID-19 can lead to severe illness, personal injury, permanent disability, and death.** **Participating in the Reunion could increase the risk of contracting COVID-19.** Camp Timanous, its officers, directors, agents, employees, and successors in no way warrant that COVID-19 infection will not occur through participation in our Programs and expressly disclaim all liability therefore. I understand that I am solely responsible for evaluating the risks of COVID-19 associated with participation in the Reunion.

Waiver, Release, Indemnification & Covenant Not to Sue

In consideration for, and as a condition of my and/or Participant's participation in Programs, I, the undersigned, agree that Camp Timanous, its officers, members, directors, agents, employees, volunteers, successors, or representatives (collectively "Releasees"), will not be liable for any personal injury, property damage, medical expenses, loss, disability, death, sickness or disease incurred by myself and/or Participant, on account of or in any way relating to or arising out of my presence at Camp Timanous or involvement in Programs, including but not limited to the **negligence** of Releasees.

I further agree, on behalf of myself and/or Participant, and all legal successors and proxies, to release and **HEREBY DO RELEASE, WAIVE AND COVENANT NOT TO SUE** Releasees from any causes of action, claims, suits, liabilities or demands of any nature whatsoever including, but in no way limited to, claims of negligence, which myself, and any and all legal successors and proxies may have, now or in the future, against Releasees on account of personal injury, property damage, disability, death, sickness, disease or accident of any kind, arising out of or in any way related to the use of Facilities or participation in Programs, however the injury or damage occurs, including but not limited to, the negligence of Releasees. This waiver and release is intended to and does release Camp Timanous from any and all liability for damages or injuries on account of or in any way related to or growing out of my negligence, the negligence of third parties and Camp Timanous' negligence. This is not intended to release Camp Timanous from any liability resulting from their intentional conduct.

In further consideration of my use of Facilities and participation in Programs, I covenant and agree not to institute any claims or legal action against Camp Timanous for any claim released by this Agreement. I, the undersigned, agree to **INDEMNIFY (reimburse) AND HOLD HARMLESS** Releasees from and against any and all causes of action, claims, demands, suits, liabilities, costs or expenses (including reasonable attorneys' fees) of any nature whatsoever, including claims of negligence, arising out of or in any way related to my use of Facilities or participation in Programs.

I understand that Camp Timanous is not responsible for any lost, stolen, or damaged valuables or property.

I acknowledge that I have received, read and understand the Guidelines listed above and policies below and received and read the Safety and Waterfront Regulations enclosed. I agree that I will fully comply with all rules and regulations.

I certify that I am signing this Agreement freely, voluntarily and competently and that I am at least eighteen (18) years of age. I further acknowledge and agree that I have not relied on any representations, statements or inducement apart from this Agreement, the Guidelines above and Policies below, whether oral or written by Camp Timanous or anyone associated with Camp Timanous.
